While also providing Clients with the ability to use RM3 in conjunction with LHC's supply frameworks, such as Kitchens and Associated Products (K7), Doorsets, Fire Doors and Communal Entrance Doors (C8) and Windows & Doors - PVC-U & Timber (WD2).

The tender was carried out in strict accordance with the UK Public Contracts Regulations. Places on the framework were awarded to 35 companies across five workstreams. The companies appointed to the framework are experts in their field, with a proven track record in delivering projects with public sector Clients.

The term of the framework is from 1st March 2024 to 29th February 2028. Individual call-off projects can be completed beyond the four-year duration of the framework, as long as the project has been formally awarded prior to the framework expiry date.






